



# Terms and Agreements

Language used during the event should be rated as PG-13. Each person will be allowed up to three warnings for poor conduct or individual behavior for the duration of the event.

Individuals will receive a warning if they are behaving outside the scope of this agreement. Individuals that exceed three warnings may be removed from the event at the discretion of the Event Manager.

## **Individual Conduct**

Any serious offences such as intentional damage caused to equipment or physical attacks or abuse of other attendees, or staff will not be tolerated, and will result in the immediate removal and/or disqualification of the parties involved from the event and the venue by event staff. The event Manager reserves the right to disqualify or remove any such parties from the event and premise without warning. Parties that are removed from the venue or disqualified from the event under the aforementioned circumstances will have no claim to financial compensation and may be liable to pay the Event Manager compensation for any damages resulting from their actions. The decision lies solely at the discretion of the Event Manager.

## **Venue Rules**

Individuals will be subject to bag inspections whenever entering or leaving the venue at the discretion of the Event Manager and Staff. Refusal to cooperate with this condition by any individual will prevent them from entry into the venue and participation in the event, and can result in disqualification and/or removal of the individual from the venue and the event, at the discretion of the Event Manager and its Staff.

## **Prohibited Drugs**

Individuals warrant that they will not take any illegal drugs, abuse any prescription or over the counter drugs nor take any performance enhancing drugs. Anyone using illegal drugs will be removed from the event. Anyone who is found intoxicated or in the possession of alcohol will be removed from the event.

## **Damage Liability**

All individuals and attendees release the Drumheller Dinosaur & Comic Expo, Sykes Events, and its staff at the event from any and all claims for damage, loss or personal injury arising from or relating to an individual's participation in the event and all liability and obligation to the individual of any and all nature whatsoever arising out of or in connection with the exercise of the rights granted herein including, without limitation, from any liability for violation of rights of privacy, publicity, defamation, emotional distress or any similar right. The individual(s) hereby indemnify the Drumheller Dinosaur & Comic Expo, Sykes Events and the Staff from and against all claims, actions, losses, damages, judgments and liabilities resulting from any breach of this agreement and/or any actions or omissions by the individual(s) while participating in the event. In no event shall the Individual(s), and the individual(s) hereby irrevocably waive, any right to sue the Drumheller Dinosaur & Comic Expo, Sykes Events or the Staff or seek or obtain injunctive or other equitable relief in connection with the event, the advertisements or any other productions, or the production, distribution, exhibitor or other exploitation, or the advertising, promoting or publicizing of the event.





## **Material Release**

The attendee hereby grant to the Drumheller Dinosaur & Comic Expo and Sykes Events a worldwide, irrevocable, perpetual, non-exclusive, transferable, royalty-free license, with the right to sublicense, to use, copy, adapt, modify, distribute, license, sell and make available for streaming or an on demand service (or download or as part of a subscription service), transfer, publicity display, publicity perform, transmit, stream, livestream, broadcast, access, view, and otherwise exploit such Original Content (as hereinafter defined) and any and all videos, shows, broadcasts, digital media, promotional and marketing materials.
